- The application must be at least 15 years old.
- The application is only valid for youth accommodation/student's halls of residence and is not applicable or transferable to when applying for general apartments.
- The application is personal and cannot be completed on behalf of any other person nor is it transferable to any other person.
- In order to qualify for youth accommodation, the applicant must be undergoing a full time course of education/vocational training. (Traineeship or SU-legitimised education programme).
- The resident must at all times be able to document his or her participation in a full time course of education/vocational training cf. Announcement of termination of tenancy in government supported youth-housing §3; In case of lacking ability to provide required documentation, the tenancy can be terminated with three months notice.
- If no applicants are undergoing a full time course of education/vocational training, the accommodation will be let out to other interested parties.
- Please be aware that neither the Danish postal service nor the national register will inform us in case of any changes in address. Therefore please always remember to inform us of any such changes.

### **If you want to avoid unnecessary waiting time**

#### **- Facts and advice, when applying for youth accommodation**

- Apply for accommodation well in advance and be meticulous when completing the application form.
- Do not only apply for accommodation which centrally located; as a general rule the waiting time increase the close the accommodation is to the city centre / educational institutions.
- Normally the waiting time, for low-rent accommodation and accommodation with private bath/toilet, will be the longest
